## INVITATION TO BID FOR THE DESIGN, SUPPLY, INSTALLATION & COMMISSIONING OF WIRELESS COMMUNICATION FACILITIES WITH 50FT. GUYED TOWER AND NETWORK COMMUNICATION DEVICES

- 1. The ANGELES CITY WATER DISTRICT (ACWD), its Bids and Awards Committee (BAC), through its Corporate Budget for CY 2015 intends to apply the sum of *One Million Eight Hundred Pesos* (*PhP1*,800,000,00) being the Approved Budget for the Contract (ABC) to payments under the contract for the *Design*, *Supply*, *Installation & Commissioning of Wireless Communication Facilities with 50ft. Guyed Tower and Network Communication Devices*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The ACWD-BAC now invites Bids from eligible Bidders should posses a valid NTC License application to the contract, have a similar contract with a value of at least 50% of the ABC, and have key personnel and equipment (listed in the Eligibility Forms) available for the prosecution of the contract. Bidders should have completed, within the last three (3) years before the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act". Bidding is restricted to Filipino citizens/sole proprietorships, organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5083 and subject to Commonwealth Act 138.
- 4. Interested bidders may obtain further information from ACWD BAC Secretariat and inspect the Bidding Documents at the address given below during Monday to Friday from 8:00 a.m. to 12:00 nn. only.

- 5. A complete set of Bidding Documents may be purchased by interested Bidders starting June 3, 2015 from 8:00 a.m. to 12:00 noon only from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of Five Thousand Pesos Only (Php5,000.00).
- 6. The ACWD-BAC will hold a Pre-Bid Conference on June 9, 2015, 10:00 a.m. at the ACWD Administration Building, Pampang Road, Angeles City, which shall be open only to all interested parties WHO HAVE PURCHASED THE BIDDING DOCUMENTS. To ensure completeness and compliance of bids, bidders are advised to send not more than two (2) technical and/or administrative representatives who will prepare the bidding documents.
- 7. Bids must be delivered on or before June 22, 2015, 10:00 a.m. at 1<sup>st</sup> Floor, BAC Secretariat, Administration Building, Pampang Road, Angeles City. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18. Bids submitted beyond 10:00 a.m. will be disqualified to join the bidding process.
- 8. Bid opening shall be on June 22, 2015, 10:01 a.m. at Administration Building, Pampang Road, Angeles City. Bids will be opened in the presence of the bidder or his/her duly authorized representative at the address below. Late bids shall not be accepted.
- 9. In any cases of the above dates is declared a special non-working holiday, it will automatically be reset on the next working day.
- 10. The ACWD BAC reserves the right to accept or reject any bid, declare a failure of bidding, not award the contract, annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders. Further, the ACWD reserves the right to waive any minor defects of formality and to accept the proposal most advantageous to the agency.
