

Contract Agreement Form

THIS AGREEMENT made the 10th day of Sept. 2020 between ANGELES CITY WATER DISTRICT of the Philippines (hereinafter called "the Entity") of the one part and DRAGONTRADE CHEMICAL AND INDUSTRIAL CORP. NO. 11 BMW ST. VILLAGE EAST, BARANGAY STO. DOMINGO CAINTA, RIZAL (hereinafter called "the Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., *Supply and Delivery of One Hundred Forty (140) drums of Granular Calcium Hypochlorite for Angeles City Water District* and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of *Eight Hundred Thirty Six Thousand Five Hundred (Php 836,500.00)*

3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
